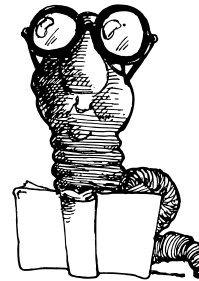


Scavenger Hunt
